## State Government Affairs (SGA)

### REGIONAL COMMITTEES

#### California

Covers California and Hawaii.

#### Western

Covers Alaska, Arizona, California, Colorado, Idaho, Montana, Nevada, New Mexico, Oregon, Utah, Washington, and Wyoming.

#### Southern

Covers Alabama, Arkansas, Florida, Georgia, Louisiana, Mississippi, North Carolina, Oklahoma, South Carolina, and Tennessee.

#### Texas

Covers Texas.

#### Midwest

Covers Illinois, Indiana, Iowa, Kansas, Kentucky, Michigan, Minnesota, Missouri, Nebraska, North Dakota, Ohio, South Dakota, and Wisconsin.

#### Northeast

Covers Connecticut, Delaware, the District of Columbia, Maine, Maryland, Massachusetts, New Hampshire, New Jersey, New York, Pennsylvania, Rhode Island, Vermont, Virginia, and West Virginia.

### ISSUE-BASED COMMITTEES

#### Tax

Monitors and advocates on tax policy at the state legislative and regulatory level.

#### Environment

Advocates on environmental legislation and regulations in each of the 50 states.

#### Procurement

Advocates for reforms of procurement policies and procedures in all 50 states.

#### Privacy

Monitors all legislation within the online privacy sphere.

#### Workforce & Education

Focuses on education policy discussions taking place across the country.

#### Emerging Technologies

Supports the maturity and growth of emerging technology platforms through impactful policies at both the Federal and State level.

## Federal Policy

**Tax** - Focuses on tax reform to lower the corporate rate, move to a territorial system, and other nexus issues.

**21<sup>st</sup> Century Workforce** - Addresses high-skilled immigration proposals, STEM education and workforce pipeline issues

**Broadband & Telecommunications** - Advocates for policies that impact the Internet economy to ensure innovation and economic growth

**Cybersecurity** - Addresses the most pressing concerns including critical infrastructure security, workforce, business best practices, and supply chain.

**Privacy and Data Security** - Seeks the proper regulatory balance between promoting innovation and protecting personal information.

**Emerging Technologies** - Examines policies that govern issues surrounding Internet of Things (IoT), smart communities, artificial intelligence, automation, unmanned aerial vehicles (UAVs), blockchain technology, and quantum computing.

## International Policy and Regulatory Compliance (IPRC)

### Customs

Works with U.S. and foreign governments to make Customs procedures effective and transparent.

### Export Controls

Works with the U.S. Congress and the Administration to streamline U.S. export controls.

### Global Trade and Market Access

Develops and advocates for trade policies that support the growth of the tech industry and works to reduce barriers to help companies succeed in global markets.

## Human Services IT Advisory Group (HSITAG)

**Marketing & Social Media Working Group:** Elevates our presence in the market and increase engagement using social media and emerging technology.
