Overview

The European Cybersecurity Skills Framework (ECSF) is a tool to support the identification and articulation of tasks, competences, skills and knowledge associated with the roles of European cybersecurity professionals. The ECSF summarises all cybersecurity-related roles into twelve (12) profiles. It provides a common understanding of the relevant roles, competencies, skills and knowledge required, facilitates recognition of cybersecurity skills, and supports the design of cybersecurity-related training programmes.

With CompTIA certifications, cybersecurity professionals can verify their cyber knowledge and skills and fulfil their skills requirements for the 12 ECSF cybersecurity-related roles.
