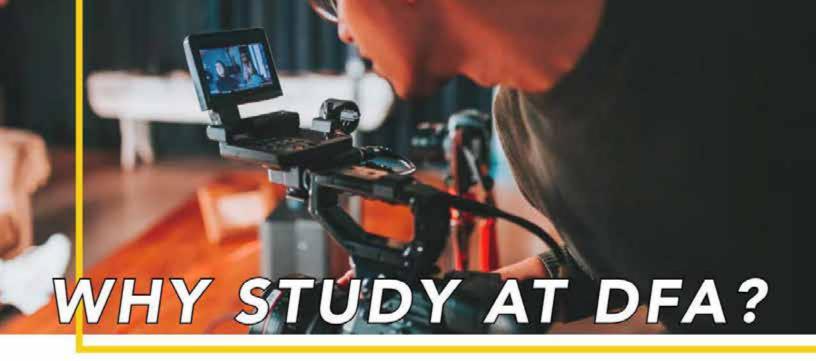

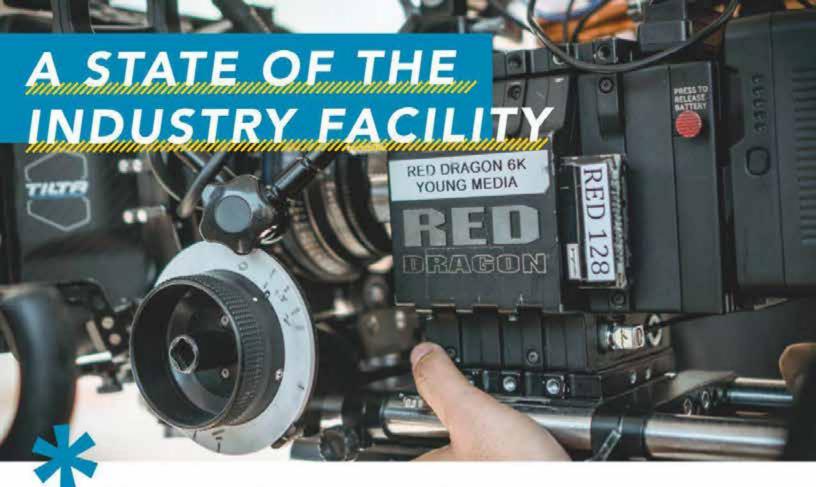

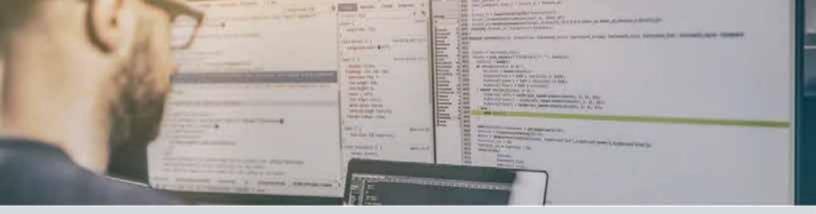

# Digital Imaging Technician (DIT)

In this course you will be taught the concepts, methods, and technical aspects of digital postproduction workflows. Class topics will include digital formats, digital media, compression, color, LUT, composition, and postproduction workflow for RAW files.

# What is DIT?

The Digital Imaging (or Image) Technician was created as a response to the transition from the long established film medium to digital media which utilizes various formats like HD, 2K, and 4K. A DIT's role is to be in charge of transferring and managing the image data, replacing the traditional film loader position.

# After Effects Motion Graphics & Visual Effects

In addition to learning the standard transform tools and import/ export procedures, students will be shown new techniques like parenting, overlay modes, 3D animation, matting and bluescreening - creating an environment of artistic creativity as well as technical training.

\*Entry Requirements: Students should be familiar with basic computer applications. Experience in Photoshop, Illustrator, and editing software a plus.

# Steadicam Course (Advanced Students Only)

This course is conducted primarily in a studio and pressents a variety of topics related to steadicam operating and techniques. The course also covers a variety of specialized motion picture equipment, including Steadicam, wireless Follow Focus, and Wireless Video, through lectures, demonstrations, and specific assignments.



# Color Correction (DaVinci Resolve)

This course touches on the basic principles of Video & audio editing, and color grading HD, 2K and 4K with Black Magic's DaVinci Resolve software. Input, edit and output/finalize within Resolve. Students who enroll in this class may take the Black Magic certified exam.



# Documentary Theory & Practice

This course provides students with an understanding of the theory and practice of documentary filmmaking, from concept through post-production. Class discussion topics will include; the issues and challenges of documentary production-style, approach, ethics, verisimilitude, logistics, locations, research, interview techniques, treatment writing, shooting, post-production editing, production books, and new technologies. Classes will be made up of in class discussions and screenings of parts of documentaries. Upon completion of this course, students will have written their own documentary treatment.

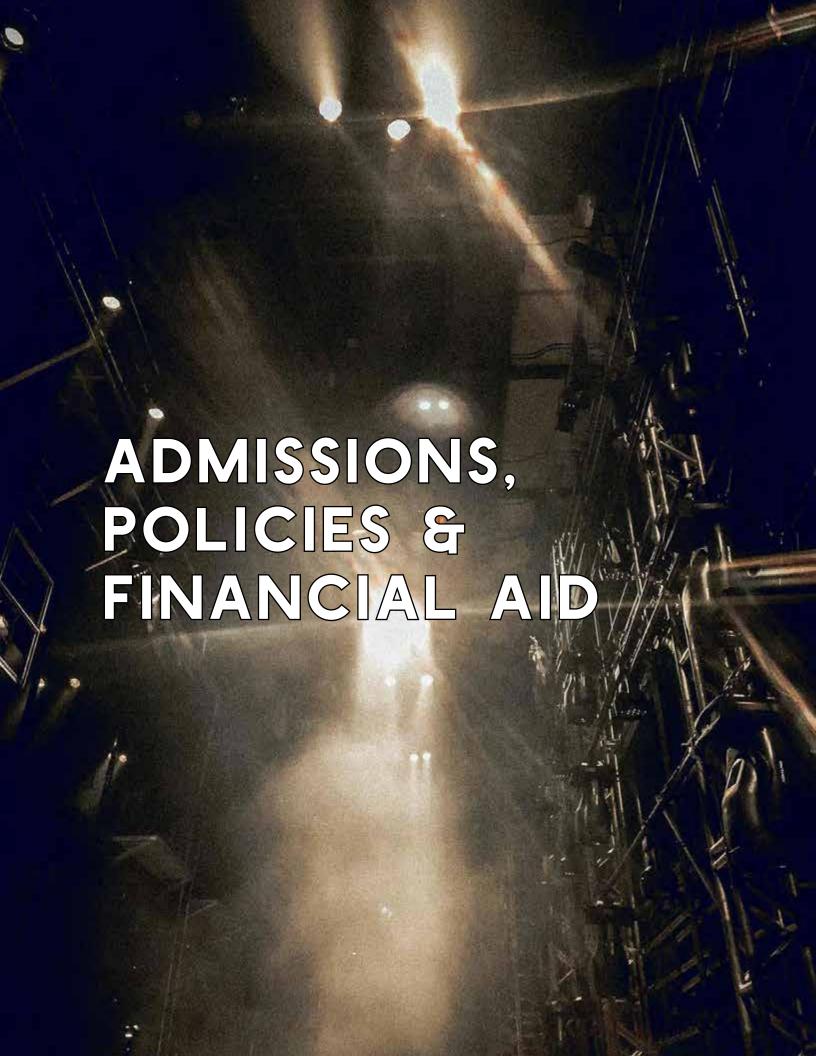


# Web TV Production - Monetize Your Media! TM

# Introduction to 3D Animation

Students will learn how to model a digital character, rig it for 3D animation, create an animation and render a final product. The class is designed to foster an environment of creativity as well as learning technical skill. The lessons taught in this course will create a solid basis which students will be able to use in any 3D project they choose to take on.

# ADMISSIONS POLICY

# Admissions Process

An individual who seeks admission to Digital Film Academy will be interviewed either in person, via telephone, video conference, or e-mail by a member of the Admissions department. The purpose of the interview is to discover and discuss the prospective student's background, interests, and goals as they relate to programs, workshops, and courses offered at the academy. A visit is not a requirement for submitting the application. Additionally, the interview can help identify the most appropriate program, workshop, or course that is consistent with the student's background, interests and goals. Prospective students may also receive information concerning curriculum offerings and support services available to students and graduates. Finally, the preadmission interview can help assess whether a prospective student has a reasonable chance of successfully completing the appropriate program of study. Prospective students who are interested in additional information and further discussion on Digital Film Academy curriculum and programs may make an appointment to speak with the Director of Admissions for an interview or tour of the academy. A minimum HS Diploma or GED is required to attend Digital Film Academy. All transfer requests will be evaluated by the Office of Student Services and a Digital Film Academy Director. An interview and portfolio review with a Director may be required to ensure the transferring student possesses the necessary educational experience and skills to successfully move within his or her studies at Digital Film Academy and that the overall educational experience will fulfill vocational objectives.

# Transfer Hours/Outside the Academy

### Veteran Transfer In Hours Policy:

In accordance with VA requirements, this institution will inquire about each veteran or veteran benefits eligible person's previous education and training, and request transcripts from all prior institutions, including military training, traditional college coursework and vocational training. Previous transcripts will be evaluated and hours will be granted, as appropriate. Please be advised however that Digital Film Academy is a clock hour school and the granting of prior hours is not appropriate or possible. Requests must be submitted to the Office of Student Services.

### Application and Enrollment

An enrollment agreement must be completed and signed by the applicant (and parent or guardian if applicable) for all programs and courses. For all programs, an application must be submitted with no application fee at the time the application is submitted. All applicants have 7 days from the date of signing the Enrollment Agreement to cancel without incurring any fees.

# Orientation

An orientation program is held for all new students. Students will be advised of the date and time. Attendance is mandatory for all new students.

# Student Visa

This school is authorized under federal law to enroll F-1 nonimmigrant students.

# Class Size

Classes are limited to 10 to 15 students.

# Trimester System

Digital Film Academy follows a trimester system, in which the academic year is divided into instructional terms, which are 16 to 18 weeks of instruction. Three terms equal an academic year.

# Clock Hours

- Course work at Digital Film Academy is measured in clock hours.
- For all programs, one clock hour is defined as 50 minutes of instruction in a 60-minute period.
- For workshops, one clock hour is defined as 60 minutes of instruction in a 60-minute period
- For courses, one clock hour can be defined as 50 minutes in a 60-minute period OR 60 minutes in a 60-minute period, depending on the course.

# Grading System For Full-Time Programs

Students must maintain a cumulative 1.5 GPA to graduate and receive a Certificate. The grade will largely be determined by each student's attendance, participation, and successful completion of class exercises and assignments, including a final digital film project.

Progress records are provided to students including grades, transcripts and completed programs and are maintained for a minimum of 3 years.

# Grade Appeal Process

A student who believes he or she has been improperly graded must first discuss the matter with the instructor. If the student is not satisfied with the instructor's explanation, the student, no later than ten days after his or her discussion with the instructor, may submit a written appeal to the President, with a copy of the appeal also sent to the instructor. Within ten calendar days, the President consults with the instructor to ensure that the evaluation of the student's performance has not been arbitrary or capricious. Should the President believe the instructor's conduct to be arbitrary or capricious and the instructor declines to revise the grade, the President, may appoint an appropriate member, or members, of the faculty of that subject to evaluate the performance of the student and assign a grade.

Once a student submits a written appeal, this document and all subsequent actions on this appeal are recorded in written form for deposit in a department or college file.

# Financial Aid Programs

Digital Film Academy participates in the Title IV Federal Student Financial Assistance programs. Students who are U.S. citizens or permanent residents may qualify for one or more of the following financial assistance programs. To apply for financial aid, students must complete the "Free Application for Federal Student Aid" (FAFSA) which is available through the Financial Aid Office or online at www.fafsa.ed.gov. Financial Aid Administrators are available at each campus to assist students with their financial aid applications and questions.

# Eligibility Requirements

Student financial aid applicants must satisfy certain eligibility requirements in order to be able to receive and continue to use financial aid. These requirements include, but are not limited to:

- Fulfillment of all admission requirements;
- Submission of all documentation requested by the school or lender(s) or both;
- Satisfactory academic progress in accordance with school policy;
- Completion of "aid specific" requirements, such as entrance and exit loan counseling; and
- Remain a student in good academic standing.

In addition, graduating students who received student loans must attend exit loan counseling sessions and meet all other graduation requirements before they will be considered a graduate and awarded a credential. Withdrawing students who used any loans must attend exit counseling.

# Federal Pell Grant Program

The Federal Pell Grant program is the foundation of the federal government's financial aid programs. The Pell Grant, unlike the loan, does not have to be repaid. If qualified, the Pell Grant amount will be determined by formulas established by the U.S. Department of Education. Please check with the Financial Aid Office for award minimums and maximums.

# Federal Direct Stafford Loan Program

(subsidized or unsubsidized)

A student loan is a low-interest loan made to you by the U.S. Department of Education. Funds are paid to the student by the federal government through a direct credit to the student's account. The eligibility and annual maximums for the Federal Direct Student Loan (FDSL) Programs and Federal Direct PLUS Loan Programs are established by federal regulation. Federal Direct Stafford Loans are low interest loans made to students attending school at least halftime. Federal Direct Stafford Loans, unlike grants, are borrowed money that must be repaid, with interest and payments normally beginning six months after leaving school. The amount of each payment depends on the size of the debt and the ability to pay. Students can qualify for a Federal Direct Subsidized Loan based upon financial need, as determined by the FAFSA. The needbased loan (referred to as "subsidized") offers in-school interest subsidies by the federal government. In addition, students may qualify for a non-need Federal Direct Unsubsidized Stafford Loans (referred to as "unsubsidized"). These loans do not offer interest subsidies. It is possible for students to have both subsidized and unsubsidized Federal Direct Stafford Loans.



# Loan Limits

An independent undergraduate and dependent students whose parents are unable to borrow a PLUS loan can borrow up to \$3,500 from the subsidized loan and up to \$6,000 from the unsubsidized loan for the first academic year. Student loan programs are also subject to total (aggregate) borrowing limits. These limits include all loans that the student has borrowed while attending any school. The maximum aggregate loan limits for dependent undergraduate students are \$23,000 from the subsidized loan and \$31,000 from the unsubsidized loan program. Independent undergraduate students and dependent students who are unable to borrow from the PLUS program have aggregate limits of \$23,000 from the subsidized loan and \$57,500 from the unsubsidized loan program. All students are required to participate in an Entrance and Exit Interview to ensure the student fully comprehends the rights and responsibilities of a borrower loans begins six months after ceasing enrollment. Repayment on unsubsidized loans including interest also begins six months after ceasing enrollment, but interest begins accruing at time of first disbursement.

Students may choose to repay the accrued interest while in school which reduces the cost of borrowing. If the borrower chooses not to pay the interest on the unsubsidized loan while in school, the interest will be capitalized (added to the principal) and the new loan amount will begin to accrue interest costing the borrower more over the life of the loan.

# Federal Parent Loans for Undergraduate | Students (PLUS)

Federal PLUS Loans are for parents to borrow to help pay for their children's education. These loans enable parents with good credit history to borrow for each dependent. Federal PLUS Loans must be repaid. Repayment generally begins 60 days after the loan is fully disbursed. The maximum amount that a parent can borrow on behalf of their child is the difference between the cost of attendance and other aid received.

# Financial Aid

# Title IV Funds (R2T4) Policy

In the event that a student withdraws from all courses, regardless of the reason, s/he may no longer be eligible for the full amount of TIV funds originally awarded. The return of funds to the federal government is based on the premise that a student earns financial aid in proportion to the length of time enrolled. A pro-rated schedule determines the amount of federal student aid funds earned at the time of full withdrawal. For example, a student who withdraws in the second week of the program has earned less of his/her financial aid than a student who withdraws in the fifth week. Once the 60% point in the program is reached, a student is considered to have earned all of the financial aid originally awarded and will not be required to return any funds.

# Veterans Education Benefits

Qualified veterans and dependents are eligible for educational benefits while attending certain programs at Digital Film Academy. With a few exceptions, programs offered are approved for the training of veterans by each State's Education Department. Contact the Financial Aid office for an updated listing of eligible programs. The veteran and/or dependent may be eligible to receive funding from one of the following chapters:

# Veterans Refund Policy

In the event that veterans or their eligible dependents sponsored as students under Chapters 30, 31, 32, 33, 35, of Title 38 and Chapter 1606, 1607 of Title 10 U.S. Code fail to enter the program or withdraw or discontinue attending at any time prior to completion, the amount charged for tuition, fees and other charges shall not exceed the approximate prorata portion of the total charges for tuition, fees and other charges that the length of the non-accredited program bears to its total length. A registration fee of \$10 need not be refundable; any amount beyond that is subject to proration and refund [CFR 21.4254 (c) (13)]. The prorata portion may not vary more than 10 percent of the total costs for tuition, fees, and other charges.

# Academic Standards Related to Federal Financial Aid

In order to continue to qualify for federal financial aid programs, students must maintain satisfactory academic progress standards. These standards are outlined in the Academic Standards and Policies section of this catalog.

**NOTE:** The failure of a student to immediately notify the Executive Director in writing of the student's intent to withdraw may delay a refund of tuition to the student pursuant to Section 5002 (3) of the New York

# Tuition Liability

Under New York law, tuition liability is divided by the number of quarters or terms in the program, workshop, or course. Total tuition liability is limited to the quarter or term during which the student withdrew or was terminated and any previous terms or quarters completed. In accordance with school policy, the academy will earn tuition and fees as follows, based on the week in which the student withdraws or is terminated:

For full-time conservatory programs, workshops, or courses that are divided into Quarters, the student refund may be more than that stated above if the accrediting agency or the Federal Pro-Rata refund policy results in a greater refund. (see following page)

Title IV Student Withdrawal Policy: Title IV Student Withdrawal Policy - DFA must always return any unearned Title IV funds that it is responsible for within 45 days of the date DFA determined the student withdrew and offer any post-withdrawal disbursement of loan funds within 30 days of that date.

Withdrawal Date: A student's withdrawal date varies depending on the type of withdrawal.

Official Withdrawal: To begin the withdrawal process, the student must contact the Office of Financial Aid to obtain the appropriate withdrawal form.

Unofficial Withdrawal: In a case when the student does not provide official notification to withdraw, DFA may use the midpoint of the payment period or 14 days from last attendance (whichever is later) as the date of withdrawal.

Date of Last Attendance: DFA may also use the withdrawal date as the student's last date of attendance reported by a faculty member on a course enrollment roster or final grade sheet. The instructor will maintain documentation of the last date of attendance.

Date of Institution's Determination of Student Withdrawal: The date of DFA's determination that a student withdrew varies depending upon the type of withdrawal.

Date of Official Notification Provided: This is the date the student provides official notification to DFA or begins the withdrawal process, whichever is later.

Date of Official Notification Not Provided: This is the date that DFA learns the student has ceased attendance. DFA will perform the Return to Title IV Funds calculation and return any unearned funds no later than 45 days after the end of the payment period determining the withdrawal date.

Rescission of Withdrawal: DFA may allow a student to rescind an official notification to withdraw by having him/her file a written statement that he/she is continuing to participate in academic activities and intends to complete the enrollment period.

Calculation of Earned Title IV Assistance: U.S. Dept. of Education software is used to perform all refund calculations. A copy of the completed calculation worksheet will be kept in the student's file in the Office of Financial Aid.

Refund of Unearned Funds to Title IV: If the total amount of Title IV grant and/or loan assistance that was earned by the student is less than the amount that was disbursed to the student as of the withdrawal date, the difference between the two amounts will be returned to Title IV programs and no further disbursements will be made.

Refunds by Digital Film Academy: In the event that DFA is responsible for returning funds to Title IV programs, the funds will be returned in the order prescribed by the U.S. Department of Education within 45 days of the date of determination of a student's withdrawal.

Refunds by the Student: In the event that the student is responsible for returning grants funds to Title IV programs, DFA will notify the student within 45 days of the date of determination of his/her withdrawal.

Payment Period or Enrollment Period: Withdrawals and the return of Title IV funds will be based on a payment period for all standard term programs. Non-term program payments will be based on an enrollment period.

**Documentation:** DFA must document a student's withdrawal date and the date of determination that the student withdrew. The documents will be kept in the student's academic file in the Office of the Registrar. The Title IV funds calculation and other accompanying documentation will be secured in the Office of Financial Aid.

# Satisfactory Academic Progress

The performance of all students in each course of study in all Digital Film Academy Certificate workshops and programs is evaluated on the A-F letter grade system. Letter grades are then translated into the standard four point collegiate grading scale. Students must maintain a cumulative average of 1.5 or better (on the four point scale) in order to remain in good academic standing at the Digital Film Academy.

Satisfactory Academic Progress is evaluated at the end of each semester (three times per academic year). Students who fail to meet this standard are subject to Academic Warning, Probation, or Dismissal from the Workshop or Program, and the Academy as a whole. While on probation, a student remains eligible for financial aid, however, in the event that a student is dismissed he/she may be liable for the return of a portion of specific loans or grants as detailed in the Title IV refund policy.

# Academic Warning/Probation

In order to remain in a particular workshop or program, students who have been placed on Academic Warning or Probation, must earn a grade of 2.0 or better in all subsequent courses. Students may complete additional coursework assigned by the instructor who gave the "Fail" grade in order to improve the grade to 1.0 or better and earn credit for the course.

Students will receive a warning if they fall below a 2.0, and falling below 1.5 will trigger academic probation. Students who do not meet SAP will be placed on Financial Aid Probation for the next semester of enrollment. Financial aid will be received during the semester of probation. Students who meet SAP during the semester of probation will automatically be removed from probation at the end of the term. During the semester of probation, students are encouraged to seek assistance advances, invitations, or comments for help with academic or personal problems.

At the end of the semester of probation, the student must again be meeting SAP requirements or he/she will be placed on Financial Aid Suspension.

## Academic Probation means:

- Any student who is absent more than 15 percent of the total number of instructional hours offered during each marking period, excluding approved leaves of absences and who has not maintained satisfactory academic progress, shall be dismissed or placed on academic probation.
- Any student who fails to meet satisfactory academic progress at the end is any marking period, regardless of attendance, shall be dismissed or placed on academic probation.
- The school shall dismiss any student who at the end of such academic probation fails to raise his or her cumulative grade to 2.0 and who fails to maintain attendance the probationary period.
- During a students academic probation, the school shall make available to the student appropriate counseling and remediation.

# Prevention of Sexual and Other Unlawful Harassament Policy

Digital Film Academy (DFA) is committed to a workplace and an educational environment that is free of sexual and other unlawful harassment. Sexual harassment is unlawful under Title IX of the 1972 Education Amendments. Title VII of the Civil Rights Act of 1964. As a matter of DFA policy, sexual or other unlawful harassment occurring in the course of any DFA activity is prohibited. Harassment on the basis of race, religious creed, color, national origin, ancestry, disability, marital status, medical condition (cancer-related or genetic-related), sexual orientation, sex, age, or any other protected status under federal, state or local law, ordinance or regulation applicable to the school, is a violation of this policy. Any such harassment of any individual in the course of any DFA-administered program, job or activity is prohibited and shall not be tolerated. DFA shall take prompt and effective corrective action to address unlawful harassment, including, where appropriate, dismissal or expulsion. The policy explicitly applies to DFA students, faculty, staff, administrators, independent contractors and all other individuals engaged in school activities Individuals who know of harassment, or believe that they have been harassed, in violation of this policy have access to the complaint procedures described below and are encouraged to utilize these complaint procedures. DFA officials are empowered and required to address harassing behavior promptly and thoroughly. An individual's filing in good faith or pursuing a complaint or otherwise reporting or complaining of unlawful, harassment or discrimination will not be the basis for any diverse decisions by the school concerning the individual student, faculty or staff member's position or status. Retaliation is prohibited. Prohibited conduct which violates State and Federal Law related to sexual harassment includes:

Harassment or discrimination based on gender

Such conduct is a violation of this policy and of law when:

Submission to, or rejection of, such behavior by an individual is used as a basis for educational or employment decisions.

Such behavior otherwise has the purpose or effect of unreasonably interfering with, or otherwise creating an intimidating, hostile, or offensive educational or employment environment.

Other harassing behavior may take a variety of forms including, but not limited to the

Verbal conduct such as epithets, derogatory comments, slurs, or unwelcome sexual

Visual conduct such as derogatory posters, photography, cartoons, drawings, gestures.

Physical conduct such as unwanted touching, blocking normal movement, or interfering with work.

Threats and demands, such as those which seek submission to sexual requests, in order to retain employment or education benefits and/or offers of job or education benefits or conditions in return for sexual favors.

Retaliation, in the form of adverse employment or educational actions, opposing, reporting or threatening to report harassment or for participating in a good faith investigation proceedings or hearings related to this policy

Harassing behavior includes conduct directed towards persons of the same or

DFA encourages all individuals engaged in school activities that know of harassment, or believe that they have been harassed in violation of this policy to utilize the following complaint procedures. A complaint should be filed promptly if an instance of harassment has occurred or is expected to occur. Unless good cause exists, complaints must be filed no later than one year after the harassment occurs. # Student Conduct

Students are expected to conduct themselves as mature and law-abiding members of both the academy and general community. Students are also expected to comply with requests of the administrative authorities of the academy for maintenance of order on academy premises. Any behavior which jeopardizes the health or safety of students or staff, or disrupts the educational activities and supporting services of the academy, is subject to review and possible penalty in accordance with the procedures and practices of the academy.

# Students should be advised that the following general rules of conduct are beneficial to everyone, especially the students themselves:

- Show respect for other students, instructors, staff and all other people you come into contact with at or through Digital Film Academy.
- Speak quietly to friends and associates when in school.
   When other classes are going on or if students are doing work, loud noise makes it difficult for fellow students to concentrate.
- Avoid profanity.
- Pay attention to your instructor in the classroom. If you have a question while the instructor is lecturing, ask your instructor by raising your hand.
- Do not have side conversations with fellow students during class.
- Show respect for the facility. Students should clean up after themselves. Please don't leave bottles, food in classrooms.
- Faculty, administration or staff fraternization with students is not permitted. Any violations may be reported to Director.
- Cell phones should be silenced while in DFA. Texting is not permitted during class.
- Audio and video recording of class sessions is strictly prohibited without DFA's expressed consent.

# The following is a list of behaviors that violate the Student Conduct Policy:

- Dishonesty, including but not limited to cheating, plagiarism, or knowingly supplying false information or deceiving the academy administrators, staff, or instructors.
- Unauthorized entry into, or use of, school facilities.
- Forgery, falsification, alteration, or misuse of school documents, records, or identification.
- Interference with the normal operations of the academy (disruption of teaching and administrative functions).
- Harassment and inappropriate behavior.

# Attendance Policy

Because of the intensive nature of the programs at Digital Film Academy, absenteeism jeopardizes a student's ability to successfully complete his or her studies. It is the student's responsibility to notify a Digital Film Academy Director and/or instructor and make up all work missed if a student finds it necessary to be absent, late, or leave early. Accumulated absenteeism in any one course will affect performance and grades. Absenteeism can result from absence, being tardy, or leaving class early. Instructors record tardiness and people leaving early in increments of 10 minutes. Any student who is absent 14 consecutive calendar days offered during each marking period of the student's program, excluding approved leaves of absence, and who has not maintained satisfactory academic progress, shall be dismissed or placed on academic probation pending a Disciplinary Review Hearing. After the Disciplinary Review Hearing, the appropriate course of action will be determined based on the student's explanation for his or her absences and the Academy's records of student's overall attendance and participation. Excessive absenteeism may result in the student having to repeat the course at his or her own cost. If a student is suspended from a workshop or program, he or she cannot continue to study with that current class. The student may return for a future program. A Disciplinary Review Hearing in a future workshop or program can result in expulsion. Students who are expelled or choose to not continue their studies after a suspension, will receive refunds in accordance with the policy outlined by the New York State Education Department, Bureau of Proprietary School Supervision.

# Re-Admission after termination for Conduct Policy Violation

Each case is examined individually including a meeting with the student and a written Incident Report. Depending on the severity of the offense(s) and the response from the student re-admission can occur in two terms, one year or termination can be deemed permanent.

# GI Bill of Education

# The following polices pertain to individuals receiving GI Bill Education benefits:

- I. Standards of Progress: Student must maintain a 75% average on academic work to take the final exam and must make 75% on the final exam to pass the attempted course. Students not achieving passing marks are encouraged to repeat class for a nominal fee (basic classes \$100, advanced classes \$200). Cheating on an examination will result in dismissal from the program.
- II. Students are expected to attend 100% of all classes. Attendance will be taken at the beginning of each class and following any breaks. 3 late arrivals or 3 early departures will be considered an absence. To maintain eligibility for GI BILL® benefits students must attend 80% of all scheduled classes as established by the Georgia State Approving Agency Veteran's Attendance Police Attached.

Attendance and academic work will be monitored on a weekly basis. If a student falls below either criterion listed above they will be placed on probation. The probation period will last for 30 days. A student who is on probation who fails to meet satisfactory academic progress standards and/or attendance will have GI BILL®education benefits terminated. If after 60 days a student who has not returned to good class standing may be subject to termination from the program. Students do have a right to appeal. Appeals must be submitted in written form to the School Director within two business days, Should a student be reinstated, credit will be granted for the successfully completed portion of the program of study. A student who fails to maintain satisfactory academic progress and attendance within 30 days of reinstatement will be terminated from school. Once terminated from school the student can reapply for admission 12 months from the date of termination. Should the student be allowed to reenter school the student will be required to restart the entire program of study and no credit will be granted for any successfully completed courses.

III. Leave of Absence Policy. Any student who begins a period of leave of absence will be terminated from GI BILL®education benefits effective the date the leave of absence begins. Students who take a period of leave of absence will be allowed to restart the program of study at the point in which instruction was interrupted. Credit will be granted for any previous course work completed. Students will be re-certified for GI BILL® education benefits after return to classes. Should a second period of leave of absence occur students will be terminated from the GI BILL® education benefits and GI BILL® education benefits will not be reinstated upon return to school unless the period of leave of absence was due to mitigating circumstances as determined by the School Director.



IV. Student Conduct Policy. Any conduct determined by school officials to be detrimental to the school, clinical facilities, or other students, or behavior that is unprofessional, will result in permanent dismissal.

This will include, but not limited to:

- a. Theft of damage of property
- Abuse (verbal or physical) of any member of the student body, faculty, or clients in the clinical setting.
- Possession or consumption of alcohol or drugs on the premises.
- d. Possession of dangerous weapons.
- e. Obscene or disorderly conduct.

A student dismissed due to conduct does have the right to appeal and the appeal must be made to the School Director within 5 business days of dismissal. Reinstatement is at the discretion of the School Director.

- V. Policy for granting credit for previous education and training GI BILL®education benefits recipients are required to provide the school with official transcripts of previous training for evaluation. Training time and tuition will be reduced in proportion to the amount of satisfactory credit from previous training and will be granted at the discretion of the school director.
- VI. Refund Policy. For individuals utilizing Veterans Affairs education benefits, the school will refund the unused portion of prepaid tuition and fees on a pro-rata refund basis. Any amount in excess of \$10.00 for an enrollment or registration fee will also be pro-rated.
